The Greater Kalamazoo World of Gymnastics Booster Club would like to invite you to participate in the 12th annual March Madness Men's Gymnastics Meet. This will be a USAG sanctioned competition for levels 4-10. Ages will be determined by the gymnast's age as of September 1, 2006. Competitors and coaches must be registered with USAG and coaches must be safety certified to be on the floor. USAG rules and policies will be followed. Coaches and gymnasts not providing USAG numbers by the meet deadline should bring proof of registration to the meet.

The meet schedule will be determined after entries are received. The final schedule will be mailed to all teams entered.

Fees: \$55.00 entry fee per gymnast level 4-10.
\$35.00 team fee per level (top three scores per event)

Deadline: Entries with payment must be postmarked by February 17, 2007.
Late entries will be assessed a \$5.00 handling fee per gymnast.
Entries will be taken on a first received basis.

Awards:

Awards will be determined by the number of entries in each age group within a level. Level 5-10 individual awards will be medals for the top three places and ribbons for additional places. Level 4 individual awards will be ribbons Team awards will be based on the top 3 scores per event, by level, regardless of age, to allow more teams to compete. Age groups will be separated for individual competition.

Rotations:

Teams with large numbers will be split into multiple rotations and must bring multiple coaches.

Refunds:

Refunds will be given up to the due date. No refunds will be given after the due date. Injury refunds after the due date will be decided individually by the meet director.

Meet Location:

The meet will be held at our 32,000 square foot facility at 2723 Kersten Court, conveniently located near I-94 and Sprinkle Road. Many motels and restaurants are within five minutes of the gym, on Sprinkle Rd. and Cork Street.

Equipment:

AAI Floor, Pommel Horse, Mushroom, Parallel Bars, Vault Table, and High Bar, Spieth Ring Tower, lowered Nissen Ring Tower, and narrow Nissen Parallel Bars are available.

Family Activities:

Within ½ hour of the gym are many activities. Activities available include 3 ski areas, indoor golf driving range and simulators, a zoo, multiple nature preserves, an air museum, laser tag facilities, museums, and an indoor water park. There is something for everyone in Kalamazoo!
